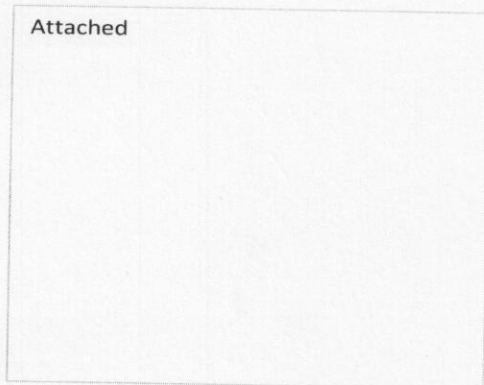
Brief Report on Inspection (Not more than 150 words)

The undersigned visited Night Shelter, Jan Pahal, 3329-30/XI, Delhi Gate, being run by SPYM at about 5.00 P.M., on 22-12-2014. The approached road (a narrow Gali) leading to Night Shelter was littered with garbage, but the Night Shelter was reasonably clean from inside. At the time of inspection 11 persons were present in the Shelter. The undersigned met Mr. Parveen, Caretaker who was on duty at that time; he informed that during night 30 to 40 people make use of this shelter. Bathrooms were usable but not very clean due to shortage of water in the Shelter. It was noticed that number of bedding was insufficient keeping the cold in mind. The Night Shelter in question is a two storied building, only Ground Floor is being used as Nigh Shelter, while First Floor is lying vacant.

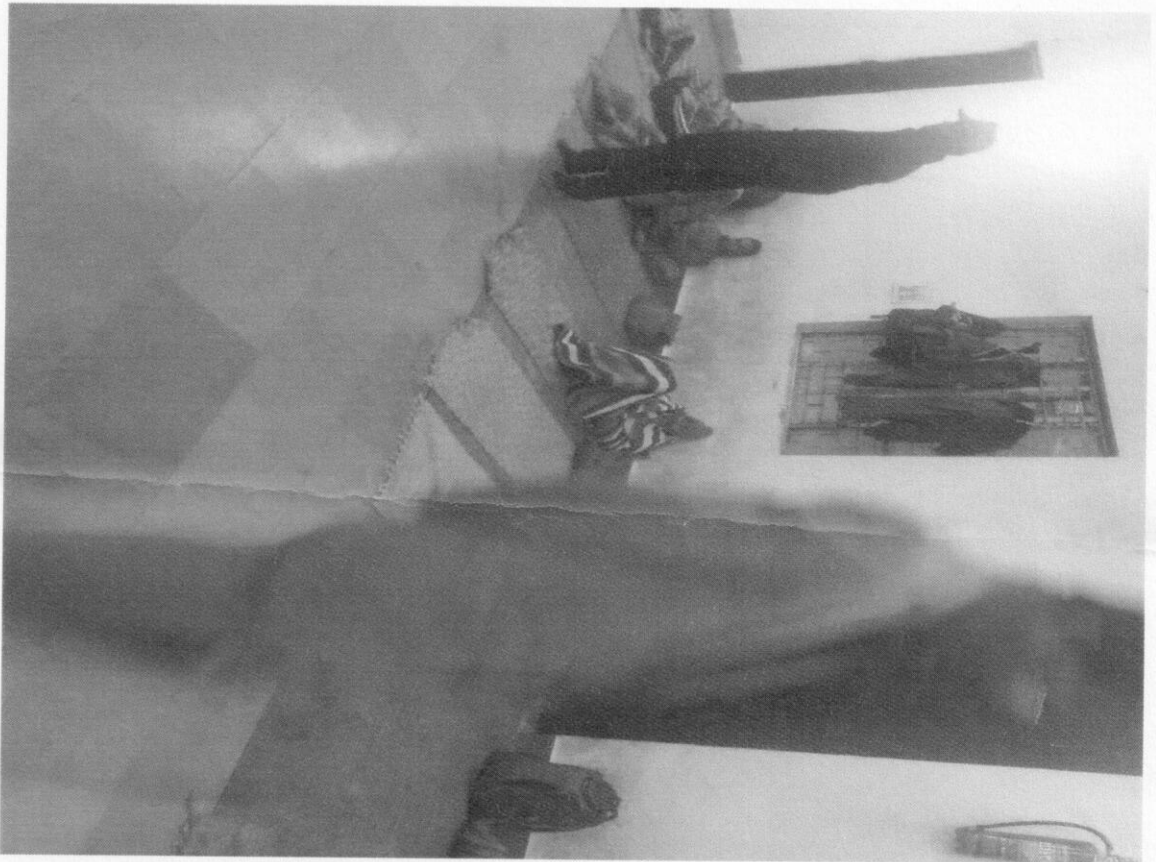
