5.	Facility of drinking water	DJB connection and Boring Water both. Water purifier installed and working. No issue of drinking water.

9.	Details of Clothing/blanket provided to inmates during night	40 blankets and 12 mattresses. Additionally inmates were also having their own blankets. No shortage.
10.	Whether there is provision of kitchen or not	Yes provision of kitchen is there. Lunch is being arranged from Sai Sandhya group at Lajpat Nagar. Evening food is cooked in the kitchen there by a cook provided by the NGO.
11.	Type of Building/tent. Whether covered/open	Pucca building. Ground floor of community hall.
12.	Arrangements for separation for Male/female inmates	No need of separation as male inmates not allowed.

13.	Lighting arrangement	Properly electricity arrangement of tube lights. Invertor also installed and functioning. Sh. Vijay Kumar Electrician (9868634693) was also found visiting the Shelter at the time of my inspection.
14.	Any other observation	<ol style="list-style-type: none"> 1. Three care-takers employed. One in each shift. Ms. Renu (9211269985) was found at the time of inspection. Others are Ms. Saroj (8447532810) and Ms. Seema (8862943320) for next shifts. 2. Fridge, TV, Invertor and two three level iron beds provided. 3. Each of the inmates was having one steel trunk donated by someone and keeping their items in lock & key. 4. Most of inmates were enjoying bright sunlight in open, as it was quite cold day. 5. None of them raise any issue about maintenance of the shelter. 6. Proper registers were maintained about inmates and also about visitors.
