It was decided that interest waiver under 1985, Special Registration Housing scheme be extended for another 06 (Six) months, on the same rate as approved by the Board earlier.
- 5. Sh. Sahi Ram, Hon'ble MLA and Member of the Board, raised the issue of allotment of rehabilitation flats to JJ dwellers of Sanjay Colony and requested to cover all left out cases also in pursuance of orders in the case of Sh. Sudama Singh. Member (Power) informed that Hon'ble High Court in the contempt petition has confined the benefit only to the Petitioners. It was desired that a status report be submitted for perusal of Chairperson / Chief Minister.

The meeting ended with a vote of thanks to the Chair.
