After due re-consideration/examination, they may put it under 'interim' or 'not resolvable', as per guidelines of PGMS. It is also directed to call back on telephone the applicant(s), where ever necessary.
- 4. Member (Admn.) also directed to mark a case 'Resolved' only when the issue has actually been resolved. If some time is needed to resolve/reexamine, put it as an interim reply, otherwise mark as 'not resolvable', unless they are the final authority themselves as per guidelines of PGMS.
- 5. All the pending/overdue PGMS cases may be disposed off by 30th May, 2017 positively, as Chief Secretary will review the PGMS status on 31/05/2017.
