**MINUTES OF THE MEETING CHAIRED BY THE MEMBER
(ADMN.) ON 25.05.2017 AT 11:00 AM IN THE CONFERENCE ROOM
AT PUNARWAS BHAWAN**

1. A meeting under the chairmanship of Member (Admn.) was convened on 25.05.2017 to discuss the issues related to 'overdue' and 'not-satisfied' category in PGMS portal. Member (Engg.) was also present. The list of AGROs/Officers, DUISB attended is attached herewith.
2. The issues related to 'not-satisfied' category were discussed in detail. It has been observed that in some cases, AGRO(s) have not uploaded the replies sent to the applicant or not examined /followed the feedback of the citizen.
3. As advised in the meeting held on 24.05.2017 under the chairmanship of Addl. Director, PGMS, GNCTD, Member (Admn.) directed to all AGROs to re-open the cases under 'Not Satisfied Category' and review/re-examine it. After due re-consideration/examination, they may put it under 'interim' or 'not resolvable', as per guidelines of PGMS. It is also directed to call back on telephone the applicant(s), where ever necessary.
4. Member (Admn.) also directed to mark a case 'Resolved' only when the issue has actually been resolved. If some time is needed to resolve/re-examine, put it as an interim reply, otherwise mark as 'not resolvable', unless they are the final authority themselves as per guidelines of PGMS.
5. All the pending/overdue PGMS cases may be disposed off by 30th May, 2017 positively, as Chief Secretary will review the PGMS status on 31/05/2017.
