Terms and Conditions for procurement of Tents

1. The tents should be made of size 30'x20' with a ground area of 600 sq. feet approx. fit for 25-30 people, wall height 6.5 feet, centre height 10.5 feet with doors and windows mosquito net provided in windows, complete with cotton ropes, steel ground fixing pegs, iron pins etc. made from 415 gsmwr strong poly canvas with steel centre poles of 16 gauge of 02 inches diameter.
2. The short term tender should give full details including complete specifications, design, installation etc. and rate of tent for supply.
3. The material/items to be used should be as per short term tender.
4. The agency shall supply the tents as per supply order mentioning the life of the tents and it will be the responsibility of Engineers of the DUSIB for installation.
5. The agency shall deposit Rs.50000/- as earnest money alongwith tender which will be refunded to the unsuccessful tenderer.
6. The agency shall mention in the bid about the provision of repairing of tents in case it require repair.
7. The payment of cost of tent will be made after the tents are supplied in good conditions and as per supply order.
8. The taxes, if any applicable, freight charges, installations cost should be included in the final quoted price of the tent.
9. The earnest money deposited will be forfeited in case the agency fail to supply the tents in the stipulated period.
10. The supply of tent shall be within 03 days from the date of issue of supply order.
11. If there is any reasons for delay in supply which are not attributable to the agency, it will be the discretion of the Competent Authority, DUSIB either to allow or not to allow the time extension.
12. Earnest money deposited will be refunded after supply of the material.
