## **ORDER**

- Visit the night shelter assigned to them at least twice a week during night time.
- They should carry with them the contact details of the agencies as well as the numbers of Rescue teams operating in the area of assignment.
- Inspection of night shelter be carried out especially to check cleanliness
  of premises, campus, toilets, availability of blankets and, durries etc and
  their state of cleanliness, water supply & storage and availability of
  other accessories.
- Teams should also check whether any homeless is sleeping in open in the vicinity of the areas assigned to them. If any homeless is found outside, the concerned agencies/Rescue Team should immediately be contacted to take them to shelter.
- They may also inform the control room of DUSIB on the telephone Nos. 011-23378789, 8527898295 and 8527898396for further action.
- They will also check that Rescue Teams are performing the job to rescue homeless of the area.
- They may also take the assistance of concerned local police and Ex. Engineer of the area.
- The inspection report in the Performa attached may be sent to Night Shelter Branch or through e-mails on e-mail ID <a href="mailto:sanjivgoel39A@gmail.com">sanjivgoel39A@gmail.com</a>
- For visiting the above night shelter, each individual will be paid an amount of Rs. 1000/- per day of inspection. The bills for re-imbursement of expenses on this account may be submitted in attached proforma and should be submitted, after due verification from night shelter branch, to accounts branch.
