NOTIFICATION

- 1. In supersession of all previous orders/ directions etc, reimbursement of medical claims of the employees/ pensioners of DUSIB for indoor medical treatment will be made as per CGHS rates notified by GOI and adopted by Delhi Govt. from time to time w.e.f. 01.04.2017. Treatment taken prior to 01.04.2017, but bills submitted after 01.04.2017 will also be decided as per CGHS Rates.
- **2.** Medical subscriptions as per CGHS norms applicable to each pay scale and Grade Pay/corresponding pay matrix as notified by Govt of India, Ministry of Health & Family Welfare vide Office Memorandum No S.11011/11/2016-CGHS(P)/EMS dated 05.01.2017 and as mentioned below will be charged from each employees w.e.f. 01.04.2017. Membership is compulsory for all eligible serving employees of DUSIB, GNCTD and for retired employees they have to opt the scheme or Fixed Medical Allowance at the time of retirement.

- **3.** The subscription rates as revised by CGHS will apply to employees of DUSIB mutatis-mutandis.
- **4.** Reimbursement of OPD medical bills to the various categories of employees will continue to be made as per the existing pattern of DDA medical scheme. It will be limited to prescribe ceiling notified/approved by the DDA from time to time till further orders.

- 5. Pensioners/Family Pensioners (old / new) will have to deposit one time Contribution i.e. 10 times of the annual subscription on the basis of pay scale and corresponding pay matrix on revision of pay scale as per their entitlement for getting medical reimbursement w.e.f 01.04.2017. In case the retired employee is getting fixed medical allowance (FMA) and wants to opt the scheme then he/she has to first apply for stopping the FMA then he/she has to deposit the requisite subscription as stated above. Only one time switchover is permissible in lifetime. Further as per Govt. of Delhi order. Pensioners/Family Pensioners who do not opt for contribution immediately can opt for paying contribution at the prevailing rates any time later on.
- **6.** Pensioners / Family Pensioners who are reluctant to give contribution / subscription will not be entitled for medical reimbursement. They will get fixed medical allowance of Rs. 500/- p.m. or as notified by Govt. of Delhi.
- **7.** All the employees/pensioners are advised to take treatment in those hospitals/nursing homes which are registered with DHS or empanelled with DDA/CGHS/MCD. CGHS rates and instructions for medical reimbursement will be applicable mutatis mutandis.
- **8.** In cases of medical advance, where the approved package rates of CGHS are not available, irrespective of major or minor diseases, then in such cases employees/pensioners are advised to obtain an estimate from Govt. Hospital for such procedures.
- **9.** The above medical policy has been approved by Delhi Urban Shelter Improvement Board in its 18th meeting held on 06.02.2017 vide agenda item no 18/24.
