Akshay Patra Payment issue

The officials of DUSIB apprised the Hon'ble Minister about the issue of pending payment of Akshay Patra Foundation and informed that the file containing the cabinet note in this regard has already been submitted by them. The Hon'ble Minister stated that the file for making provision of Rs. 10 crore for clearing the pending payment of Akshay Patra has already been forwarded to Finance Department as per directions of Hon'ble High Court.

Ghosia Colony Legal matter

The Hon'ble Minister enquired from the DUSIB officials about the status of Ghosia Colony matter pending in Hon'ble High Court of Delhi and directed that an additional affidavit be filed in the Court stating therein that the list of 82 JJ Basties in which Ghosia colony is also included has been uploaded on the website of DUSIB. The Hon'ble Minister also directed the DUSIB officials to submit the list of probable agendas for the Board meeting of DUSIB.

Matiala Assembly Constituency

Sh. Gulab Singh, Hon'ble MLA, Matiala AC briefed about the poor condition of EWS flats in Sector 16B Dwarka allotted by DUSIB in his constituency and dirty water supply in the said flats. The officials of DUSIB apprised the Hon'ble Minister (UD) that tender has already been called for this purpose but the work has not yet been awarded due to non-allocation of budget in the relevant head. So far as water supply is concerned, it was informed that letter has been written to DJB many times to

take over the services on "as is where is basis" but DJB is demanding approx. Rs. 4.37 crore as infrastructure charges. — SE (CORP)

### Hari Nagar Assembly Constituency

Ms. Rajkumari Dhillon, Hon'ble MLA, Hari Nagar AC raised the following issues:

- i) Water ATM to be installed by DJB and space for this purpose to be provided by DUSIB. — DIR (AL)
- ii) Connecting JJ Cluster drain with nearby DSIIDC drain. — SE (CORP)
- iii) Roof leakage at BVK at Mayapuri and Prayog Vihar. — SE (CORP)
- iv) Bad condition of CC pavement at entrance at JJ Cluster Macchi Market Mayapuri. — SE (CORP)

It was informed by the officers of DUSIB that a letter has already been written to DD(land) on 29.04.2023 for allocation of space for installation of Water ATM. It was apprised by DUSIB officials that JJ Cluster drain cannot be connected to nearby DSIIDC drain because level of DSIIDC drain is higher than cluster drain, hence, they are looking for other options and till then pumping out of drain water is being done by motor. Further, it was also informed annual repair and maintenance has already been done in Prayog Vihar BVK and estimate for annual repair & maintenance at WZ-B Block BVK has been prepared and work will be taken up soon.

So far as bad condition of CC pavement at entrance at JJ Cluster Macchi Market Mayapuri is concerned, it was informed that estimate has already been framed for laying CC and providing chequered tiles in lanes at JJ Cluster Macchi Market and in process of sanction.

Hon'ble Minister(UD) stated that 500 ROs are to be installed and Hon'ble CM has directed to submit information about installation of ROs in tabular form.

### Bijwasan Assembly Constituency

Sh. B.S. Joon, Hon'ble MLA Bijwasan AC raised following issues about his Assembly Constituency:

- i) Bad condition of Galis and Naalis which have not been repaired in JJ Cluster in his Assembly Constituency.
- ii) Lack of drinking water facility in JJ Camps.
- iii) No Mohalla Clinic in any Camp.
- iv) Lack basic facility of Toilets resulting into open defecation.
- v) Lack of other basic facilities like parks for children, community centre, swings etc.

The Hon'ble MLA stated that it is the responsibility of DUSIB to provide basic facilities to the residents of these JJ Camps. It was stated that due to open defecation, two children have died as they were bitten by dogs. — SE (CORP)

The officials of DUSIB apprised that only four Camps in Rangpuri belongs to DUSIB. It was also informed that forest department has issued prohibitory orders as the land belongs to forest. They provided to the Hon'ble MLA a copy of restriction order and letter written by them to DCF NW Mandir Marg for pursuing with forest department and to get NOC for repair works in JJ Camp Rangpuri Pahari, Milkpur Kohiand and JJ Camp Rangpuri Pahari Nallah.


It was also informed that minor repair work to be done at JJC Rangpuri Pahari to avoid water stagnation. It was also informed that for repair of BVK at JJC Rangpuri Pahari adequate funds are not

available with the department. It was also stated that new JSCs to be constructed in JJ Camp Rangpuri Nallah and Shanker Camp after getting NOC from forest. The copy of letter written by DUSIB to DCF was also given to MLA Bijwasan to pursue with forest department. — SE (Coord)

Hon'ble Minister directed that as special case toilets be constructed by diverting funds from other divisions. The Hon'ble Minister also directed BFO, DUSIB to submit Head wise Budget details/allocation to him within a week. SE (Coord.), DUSIB was also directed to submit the detailed report on the condition of toilets and current status of payment to the staff posted there.

The CEO, DUSIB assured that toilets be constructed in the listed JJ Clusters near to the unlisted JJ Clusters. B&FO/SE (COORD)

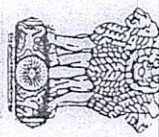
