

In this connection, I am to inform that as per the replies/information submitted by some of the above agencies/departments, none have updated their web-site and the work of installation of sign boards for the works carried out under MLALAD Scheme. However, some of the agencies/departments have provided the information as under:-

- i. NDMC, BESE-RPL, BSES-Y, TPDDL, ECIL Rapiscan Ltd. has appointed the Nodal Officer for Monitoring of Works under MLALAD Scheme in their respective department and also provided the list of development work carried out under MLALAD Scheme.
- ii. PWD, DJB & South DMC has appointed the Nodal Officer only for Monitoring of Works under MLALAD Scheme in their respective department and not provided the list of development work carried out under MLALAD Scheme.
- iii. Revenue Department, I&FC, North DMC, East DMC, Delhi Cantonment Board, DUSIB, DSIIDC, CPWD, ICSIL, DTTDC, Northern Railway, DTL and DTIDC has not appointed the Nodal Officer only for Monitoring of Works under MLALAD Scheme in their respective department nor provided any list/detail of development work carried out under MLALAD Scheme.

Secretary whose main work is to look after the works of Installation of Sign Boards & updating of Website of their concerned department for development work executed under MLA LAD Scheme for the period of 2011 to till date & provide the Name, Designation, Phone No., Official Address of the nominated Nodal Officer to this department. Moreover he will also provide the updated information as per CIC Proforma to the Urban Development Department from time to time for updating of UD department website purpose to this department by 10.10.2019 positively.
