

ORDER

In pursuance of the decision taken by the "Committee" constituted by the Order of Hon'ble Supreme Court of India for monitoring the progress of Shelter for Urban Homeless in Delhi, during its meeting held on dated 30.10.2019, vide Minutes of Meeting No.F-6(3)/DCPCR/18-19/Misc./9239-58 dated 18.11.2019, the following three Shelter Homes are hereby closed w.e.f. 20.11.2019 as under:

The DD(NS)-II shall takeover back all items issued to the said SMA for these Shelter Homes.
