ORDER

Sub: **Consolidated Revised Guidelines on the measures to be taken by Ministries / Departments of Government of India, State/UT Governments and State/UT Authorities for contained of COVID-19 in the country [As per Ministry of Home Affairs (MHA) Order No. 40-3/2020-DM-I (A) dated 15<sup>th</sup> April, 2020].**

The Ministry of Home Affairs, vide order No. 40-3/2020-DM-I (A) dated 15<sup>th</sup> April, 2020 has issued the Consolidated Revised Guidelines on the measures to be taken by Ministries / Departments of Government of India, State/UT Governments and State / UT authorities for containment of COVID-19 in the country.

The Delhi Disaster Management Authority, Govt. of NCT Delhi vide its order No F.02/07/2020/S-I/53 dated 15.04.2020 has issued directions to all the Departments of GNCTD of Delhi for strict implementation of the consolidated revised guidelines of MHA issued vide order No 40-3/2020-DM-I (A) dated 15.04.2020.


The Consolidated revised guidelines issued by Ministry of Home Affairs, Government of India vide Order No. 40-3/2020-DM-I (A) dated 15<sup>th</sup> April, 2020, *inter-alia*, states that :-

**Point No.19 (ii): Offices of the State/Union Territory Governments, their Autonomous Bodies and Local Governments will remain open, as mentioned below:**

*All other departments of State/UT Governments to work with restricted staff. Group 'A' and 'B' officers may attend as required. Group 'C' and levels below that may attend upto 33% of strength, as per requirement to ensure social distancing. However, delivery of public services shall be ensured, and necessary staff will be deployed for such purpose.*

The situation of COVID-19 in Delhi has been assessed and after due deliberations, it has been decided that GNCT of Delhi shall maintain "**status-quo**" in respect of the functioning of its Departments/Local and Autonomous Bodies/PSUs/Corporations till further orders.

This issues with the prior approval of the Hon'ble Lt. Governor, Delhi.
