Sub: OPERATING PROCEDURE FOR MOVEMENT OF STRANDED PERSONS OF MP & CHHATTISGARH DELHI BY TRAIN

State Nodal Officers for movement of stranded persons of Madhya Pradesh and Chhattisgarh have forwarded the following lists of persons stranded in Delhi due to the lockdown, for whom arrangements for transportation by train to their native States need to be made.

Madhya Pradesh Lists:

- 1. Tikamgarh- 1350 persons
- 2. Tikamgarh-1400 persons
- 3. Damoh- 1450 persons
- 4. Damoh- 1375 persons.
 - a. Madhya Pradesh Nodal Officer has certified these passengers qualify for evacuation as per Ministry of Home guidelines.
 - b. The destination Stations have been indicated as above in the title of the Lists.
 - c. The cost of train fares for these persons will be borne by the MP State Administration.

Chhattisgarh List comprises of 3261 persons.

- a. Request has been made for 1 train from Delhi to Bilaspur Junction between 14th- 17th May, 2020.
- b. The expenditure on the train fares etc will be borne by the Government of Chhattisgarh.

The State Nodal Officers of MP and CG have been requested to provide more details on the list, which will also be shared with the DMs/ DCs. However, the existing list needs to be processed immediately. The matter was telephonically discussed with the State Nodal Officer, Delhi and it was directed that the following Operating Procedure is required to be followed for the

movement of stranded migrants/persons of MP and Chhattisgarh, as per the list sent by the State Governments:

- 1. The list of stranded migrants/persons shared by the State Nodal Officers of Madhya Pradesh and Chhattisgarh will be provided to the DM/ DCs, who shall segregate the persons belonging to their respective Districts from the consolidated list.
- 2. The list of such persons identified district-wise shall be shared with the State Nodal Officer, Delhi and Nodal Officer (MP/CG) for planning the train schedule for the stranded passengers of each State based on the actual numbers identified and confirmed by the respective DMs/DCs.
- 3. For each Train, the number of persons travelling from each district will be identified and notified by the State Nodal Officer.
- 4. Concerned DMs /DCs in Delhi will set up Screening Centres for screening of such stranded persons/passengers in their respective districts.
- 5. Information about the said Screening Centres shall be communicated by the respective DCs/DMs to the persons scheduled for travel on each train and also inform them to reach the said Screening Centres at the given date and time. Care should be taken that stranded persons are intimated and called as per the schedule of the trains and not more than the specified number are intimated and called to the Screening Centres at a time.
- 6. After completion of the screening process, the said stranded persons will be transported to New Delhi Railway Station from the Screening Centres by buses/vans/taxis arranged by the concerned DMs/DCs.
- 7. Concerned DMs/DCs will make necessary arrangement for distribution of tickets to the passengers, and their proper boarding at New Delhi Railway Station.
- 8. In the entire process, the applicable guidelines regarding maintenance of social distancing, public safety and smooth passenger movement will be ensured by the local DMs/DCs.
- 9. The guidelines issued by the State Nodal Officer on 06.05.2020 for the Protocol for screening, transportation and other arrangements to be made for boarding at New Delhi Railway Station may be referred for guidance in

so far as not being inconsistent with the procedure enumerated in Point No. 1 to 6 above.

This issues with the approval of State Nodal Officer for Delhi.
