1. Eligibility for participation in the e-auction: -

- (b) Any adult individual/ Firm/ Company/ Registered Society/ Registered Cooperative Society, who is already working with DUSIB and/or registered with MCD and/or other Govt. organization as contractor or having at least one year of experience for running the parking site in any Govt. Department or Private organization shall be eligible to participate in the eauction.
- (c) Any individual/Firm/Company/Registered Society/Registered Co-operative Society/whose contract has been cancelled in the past or any of its Partner/Proprietor/ Director/Member who have been blacklisted for breach of terms and conditions of the agreement shall not be eligible for offering e-auctions, even if the Individual/ Firm/ Company/Registered Society/ Registered Co-operative Society subsequently changes the character /style/nomenclature/composition of the e-auctioner. 2. Bidders Responsibility

4. Deposition of EMD amount:

Every bidder is required to make payment of EMD online through e-auction portal (amount mentioned against each site separately). Only registered bidder who are eligible and have paid EMD online, will be able to participate in the e-auction. Bidder shall have to bid in separate e-auction document & shall have to deposit the amount as per detail in Appendix -1 as Earnest Money through online e-auction portal.

- c) The Intending bidder shall safely keep their User ID as well as password, which will be issued by the online e-auction portal upon registration, and which is necessary for e-bidding.

- 11. The bid for e-auction shall start with minimum one increment above the reserve price. Increment of rate in e-auction shall be Rs. 5,000/- (minimum increment value) or multiple thereof with a maximum increment of Rs.50,000/-.
- 12. Once the e-bid is placed, the bidder cannot reduce or withdraw it for whatever reason. If done so, the EMD amount shall be forfeited.

Time extension for bidding:

13. If any market leading bid (bid higher than the highest at the point in time) is received within the last five minutes of closing time, the time of auction sale will get automatically extended by another five minutes and subsequently, if no further bid higher than the last quoted highest bid is received within the said extended five minutes, the-auction sale will be automatically closed at the expiry of the extended five minutes and the highest bidder will become HI bidder.

Validity of bid:

14. The Validity of rates is 120 days from the date of e-bidding.

Amendment of E-auction documents:-

15. At any time prior to the proposal due date, DUSIB may for any reason, whether at its own initiative or in response to clarifications requested by a Bidder, modify the E-auction document. Any modification thus issued will be informed to all the prospective bidders by notifying on DUSIB website as well as e-auction website. Such modification will be binding upon all bidders participating in e-auction process.

Confidentiality:-

16. Information relating to the e-auction process shall not be disclosed to any person not officially concerned with the process. DUSIB will treat all information submitted as part of proposal in confidence and will not divulge any such information unless it is ordered to do so by any authority that has the power under law to require its disclosure.

Rights to accept or reject bid:-

17.CEO, DUSIB reserves the right to accept or reject any or all of the proposals /e-bids without assigning any reason whatsoever and to take any measure as it may deem fit, including annulment of the bidding process, at any time prior to award of project, without liability or any obligation for such acceptance, rejection or annulment.

Rejection of Bids:

- 18.DUSIB reserves the right to reject any /all bids without assigning any reason thereof and without incurring any liability to the affected bidder(s) or any obligation to inform the affected bidder(s) of the grounds for such decision. The DUSIB may at its sole discretion and at any time during the evaluation of proposal disqualify any Bidder, if the Bidder has:
- (i) Made misleading or false information in the e-auction process or made false documents in support of mandatory criteria.
- (ii) Submitted a proposal online that is not accompanied by required documentation or is non-responsive. In the absence of any documents as required, the concerned party shall be considered as not eligible and in that eventuality their participation in the e-auction shall not be considered.
- (iii) Failed to provide clarifications related thereto, if sought.
- (iv) Information relating to the examination, clarification and comparison of the proposals shall not be disclosed to any bidder or any other persons not officially concerned with such process until the selection process is over. The undue use of confidential information by any bidder related to the process may result in rejection of their bid.
- (v) Any superfluous documents/document not related to the mandatory criteria may result in summary rejection of bid. All participating bidders are clearly instructed to attach only those documents which are relevant to the scope of work/mandatory criteria as specified in the E-auction documents and not any other work.
- (vi) Any bidder found indulging in malicious campaign or disinformation campaign against any official of the DUSIB or any other bidders either directly or through third parties shall be considered ineligible and liable for legal actions as per law. Such bidder may also be blacklisted by the DUSIB.

Agreement:-

19. The agreement shall be executed between DUSIB referred to be as First party and the successful bidder referred to be as Second party within 10 days of issue of acceptance letter. After execution of agreement between DUSIB and successful bidder and deposit of the security amount , the parking will be handed over by Executive Engineer concerned to the successful bidder/second party on production of receipt/challan in support of payment of bid amount for the first month.

20. Payment of Security Deposit and License fee.

The earnest money of the successful bidder already deposited through online e-auction portal shall be refunded (without interest)after deposit of 25% of the bid amount in the form of Demand Draft/Bank Guarantee /FDR /RTGS as Security Amount within 10 days from issue of acceptance letter alongwith agreement entered into. The validity period of security deposit must be 60 days beyond the closing day of agreement and shall be refunded without interest to the successful bidder (i.e. Second party) after expiry of the period of agreement and handing over of the physical possession of the parking site to DUSIB. In the event of non-handing over of parking by the successful bidder to DUSIB due to any reason even after 07 (seven) days of the expiry of the agreement, the double of the proportionate bid amount of respective parking site of each delayed day shall be deducted from the security deposit as damages. In the event of Non-handing over of possession of parking and removal of temporary Khokha after 07 days of the expiry of the agreement, all erected khokha shall be got removed by the DUSIB with the help of Police at the risk and cost of successful bidder and vacant possession will be taken over by the Executive Engineer concerned and the entire security deposit of the successful bidder shall stand forfeited to DUSIB, besides other action such as recovery of damages, blacklisting, etc.

21. License fee

The License Fee of total one year period of contract shall be deposited by the successful bidder by opting any of the following options within 3 days of acceptance of the offer: -

(i) The successful bidder shall pay security deposit as per condition stipulated earlier and one month of advance license fee in the shape of Bank Draft in favour of <u>Delhi Urban Shelter Improvement Board</u> besides 11 post-dated cheques as license fee for remaining 11 months starting from the 2nd to 12th month of contract of allotment of parking site. All these payments are to be made from the corresponding Bank account of the concerned Firm/ Individual/Company whose details have been furnished to the department.

Or

- (ii) The successful bidder shall pay Security deposit as per condition stipulated earlier with one month's advance license fee and the remaining amount equivalent to 11month's license fee in lump-sum on which a rebate of 4.5% shall be allowed. This amount can be deposited through a bank draft in favour of Delhi Urban Shelter Improvement Board.
- (iii) On expiry of 1st year, from first to second year, the contractor/licensee shall have to deposit 12 post-dated cheques of license fee for 12 months of the relevant next years.
- (iv) The security deposit amount shall not be adjusted against the payment of monthly license fee in any case and shall be refunded/adjusted only after the successful completion of the contract. The security deposit will not carry any interest in any circumstances.
 - (v) The cheques for recovering payments of monthly license fee shall be sent for clearing on the 10th day of every month. In the event of dishonouring of cheques due to the reasons attributable to the Licensee/Contractor, the contract shall be deemed to have been automatically terminated, security/ earnest money will be forfeited and the licensee shall be liable to pay the damages charges @ double the monthly license fee for the unauthorised occupation. However, If the contract is not cancelled in case of dishonouring of cheques by the department in genuine circumstances, the interest @ 18% p.a shall be charged by the Department for the period of delayed payment.
- **22.** The EMD of un-successful bidder shall be refunded after allotment of Parking without interest.

23. The contract will be for a period of two years with effect from the date of handing over the site to the licensee with the condition that the Contract amount for second year shall be automatically increased at the rate of 10% of the bid amount after the completion of first year. The contract can be extended for further period of one year by the C.E.O, DUSIB, at his sole discretion with 20% enhancement at the annual license fee of previous year (i.e. second year), whose decision shall be final and binding upon the e-auctioner.

In the circumstances, if the department has not finalized the e-auction process upto the date of completion of contract period, the contract period can be further extended upto a maximum period of 3 months on same terms & conditions within which the e-auction process for awarding new contract has to be completed. The old contract will come to an end from the date of executing the new contract of parking.

24. Advertisement Boards/Kiosks may be allowed by DUSIB.

DUSIB shall reserve the right of putting up advertisements on the boundary or within the parking site either for itself, or through authorised advertiser or any other agency. DUSIB shall also reserve the right to auction such number of kiosks/ tea stalls/ other stalls etc. as may be considered appropriate in specific well demarcated areas within or along the boundary of the parking site separately.

25. Parking details:-

The successful bidder shall make arrangements for illumination and signage's on the site as per site plan to be supplied by the Executive Engineer concerned and shall clearly demarcate the parking zone of vehicles per unit for the convenience of general public within 15 days from taking over the site and shall not allow parking on more than the permissible space, failing which, a fine of Rs. 500/- per day per violation shall be imposed upon the licensee and the contract may also be liable for termination.

26. Timings:-

The parking shall remain open round the clock and the licensee shall allow parking of vehicles at all-time except due to an extraneous reasons or non-availability of parking space. However, the rates for parking shall be charged as per rates structure given in the terms & condition hereunder.

27. Rates :-

The Licensee shall be required to ensure that the following parking charges/ fee for various categories of vehicles shall be charged during the period of contract:-

28. Important Instructions: -

- (a) The successful bidder shall be required to procure hand—held machine/ computer for utilizations at the parking sites to ensure the proper and undisputed monitoring of the duration of time of the vehicle parked for charging the parking fee from the owners of vehicles.
- (b) Official vehicles of DUSIB/Govt. of NCTD and Govt. of India, MPs, MLAs shall be allowed free parking.

- (c) The successful bidder shall charge the parking charges only in conformity with the prescribed rates. The licensee shall maintain the accounts of the parking fee being charged for parking the vehicles and produce the same on demand by the licensor.
- (d) DUSIB reserves the right of revising the parking charges or any of the prescribed terms and conditions during the currency of the contract. In case of revision in parking charges, the license fee paid by the contractor shall stand revised in the same proportion for the remaining period.

- (a) The successful bidder shall be responsible for providing proper sanitation, cleanliness, lighting, water logging and prevention of encroachment at parking site;

- (b) The successful bidder shall not vend an article or allow an unauthorised vendor at the parking site. The licensee shall not permit washing / service /repair work of vehicles or nuisance of any kind, whatsoever, inside the parking site otherwise apart from the legal action of removal/demolition of such encroachment, or fine of Rs. 1,000/- per violation per day shall be imposed upon the licensee under relevant provisions of all Acts/Orders/Notifications etc as applicable, However, in such cases where vends/ stalls /kiosks are already in existence at the parking site, due to allotment by the R. P. Cell/ Zone or under court orders/ directions, the licensee shall ensure the position, location and number of such vends/ stalls/ kiosks at the time of taking over possession and confirm his acceptance/acknowledgement in writing to this effect. It will be the responsibility of the licensee not to allow unauthorised encroachment in the parking site during the currency of his/her contract otherwise the cost of demolishing such structure or for lawful eviction shall be charged from the licensee. DUSIB will be at liberty to remove encroachments inside/ around the parking site without notice. Licensee shall keep the parking site clean and tidy.
 - (c) The successful bidder shall not construct any temporary/ permanent structure, moveable or immovable otherwise he will be liable to be prosecuted. The structure so constructed shall be liable to be demolished at the risk and cost of the licensee without notice. Besides, penalty / damage charges, as may be fined by the licensor, shall be imposed upon the licensee as per Act.

30. <u>Duties of the successful bidder to deploy the employees for managing/operating the parking site.</u> No subletting allowed:

(a) The successful bidder shall manage the parking of vehicles, security of the site, cleanliness, computerisation, wherever done, either himself or through his employees. Such employees of the contractor will be in uniform while on duty and will also have identification badges on them. He /she shall not sublet or allow any other person(s) to run the parking site on his/her behalf. The successful bidder, in order to ensure civilized behaviour from his employees toward the general public, shall impart necessary training on public relation and human behaviour to his employees and will be responsible for their misconduct. The

successful bidder shall not employ any minor/ bad character person with past or present criminal record, and shall arrange for the character antecedents, verification report in respect of each of his employees at his own cost, from the police authorities under proper intimation to DUSIB.

(b) The successful bidder shall comply with the directions of local Police authorities as given from time to time.

31. Complaint register to be maintained by the successful bidder

The successful bidder shall maintain a complaint register, duly paged, at site and shall make it available to the vehicle owners to note down their complaints. DUSIB will have the right to check the complaint book as and when required. The complaint register will be kept properly and place of its availability shall be mentioned on the sign board.

32. Parking Slips:

The parking slips will display the details of location of Authorised Parking Site, name and address of the Contractor alongwith registration No. and the period of validity of contract on the slip. The records of the computerized slips shall be maintained by the Contractor and the licensor shall have the right to demand / check this record at any time and the contractor shall be bound to furnish the same within the given time frame.

33. <u>Successful bidder shall be responsible for damage/ loss to vehicles / accessories</u> during parking of vehicles.

(a) The successful bidder shall be liable and responsible for any theft of vehicle/accessories and damages/ losses caused to the vehicle during its parking at the site. DUSIB will not be responsible or liable on any account for the same and DUSIB will not be made a party to any such proceeding. Successful bidder shall mandatorily have a consolidated insurance cover for cycle/scooter/motorcycle/car etc. against loss, theft or damages etc. due to theft, riots, fire and or other natural accidents. Successful bidder shall pay the premium thereon regularly to Insurance Company and submit receipt to the Deputy Director (R.P.Cell) along with the Xerox copy of such Insurance policy Premium

receipt for verification within one month of allotment of contract. Successful bidder will make good the losses due to theft, fire damages etc. to the owner of the vehicles. Successful bidder will get the Insurance Policy renewed from time to time during the contract period, failing which his contract will liable to be cancelled /terminated.

- (b) The successful bidder shall be liable and responsible for any loss of life and physical harm to the public and payment of compensation/ damages on account of negligence on the part of licensee in maintaining the site properly.
- (c) The successful bidder shall not cause any damage to the DUSIB property either by himself or through his employees or general public. The successful bidder shall repair immediately, at his own cost, the damages that may have been (if any) caused to the parking wall/ boundary/gate/advertisements etc. as a result of negligence during the parking of vehicles. The decision of C.E.O, DUSIB will be final and binding upon the licensee with regard to liability and quantum of damages to be paid by him.
- (d) The successful bidder shall be liable and responsible for any loss/ damage caused in the parking or arising out of the parking sites and he shall indemnify and keep indemnified the DUSIB in respect of the losses or damages or expenses of litigation that DUSIB may have to incur in connection with the parking sites. An indemnity certificate will also be submitted to RP Cell within one month of allotment of the contract.

34. Wooden Khoka for use by Successful bidder, Demarcation of Site and safety of Vehicles

A wooden khokha of dimension not exceeding 10' x 8' shall be allowed to be constructed by the successful bidder at his own cost. He can remove the same after the expiry of the contract period and shall have no claim, whatsoever after that. The successful bidder shall provide parking slots either by putting white lines on the ground. The successful bidder shall ensure safety of the vehicle. The successful bidder shall not allow parking of vehicles without parking slip. The successful bidder shall ensure that the site is used in such a way that, it does not obstruct the very passage of

the vehicles parked there, only the permissible number of rows should be allowed for parking as per site map. Arrangement of lighting at the parking site will be the responsibility of the successful bidder.

35. Successful bidder to hand over possession, if so required by the licensor.

- (a) In case the site is required by the DUSIB for its own or public purposes, then the successful bidder shall hand over the vacant possession of the site to DUSIB officials at once. However, proportionate amount of license fee for the period of such disuse would be refunded to him.
- (b) DUSIB reserves the right to revise the area and change the site of parking stand in the vicinity during the currency of the contract. In case of revision of size of parking area during the currency of the contract the license fee will stand revised in the same proportion for the remaining period of the contract.
- (c) The successful bidder shall not interfere with the work of construction by the DUSIB of any drain, pipe or cable etc. and shall repair at his own cost damage which may be caused to such works to the entire satisfaction of the DUSIB.
- (d) On the expiry of the period of contract, the successful bidder shall hand over the vacant and peaceful possession of the parking site to the DUSIB.

36. Determination of License.

At the determination of the agreement for whatever cause, the successful bidder shall restore the land at the same condition in which it stood immediately before the licensee took it over and shall peacefully hand over the possession of the said site to the DUSIB.

37. Successful bidder to intimate change of address.

The successful bidder shall keep the DUSIB informed of the change in his address, change in institution etc. otherwise a communication sent at the address given to the Department shall be deemed to have been received by successful bidder. The intimation of change of address shall also be given separately to R.P. Cell for necessary amendments in the registration certificate.

38. Entry in parking lot by the licensor

The DUSIB will be entitled to enter the parking site any time for checking purposes.

39. No tenancy rights / title/ interest:

- (a) This is a license for a limited period only and it shall not contain tenancy rights enjoyable by the contractor/ successful bidder.
- (b) The land under site shall always remain the property of the DUSIB and the successful bidder shall not claim any right/ title or interest or any right or any nature of easement in relation to or in respect thereto.

40. Penalty clause:

In the event of violation of any conditions, apart from cancellation of contract, the successful bidder shall be liable to pay penalty of Rs.1,000/- (Rupees one thousand only) for violation per day. If at any point of time, the amount of penalty imposed accumulates up to Rs. 5,000/- (Rupees Five thousand only) and the successful bidder fails to deposit, it within fifteen days of the date on which the amount exceeds Rs. 5,000/- (Rupees Five thousand only), then action shall be initiated as per the provisions mentioned at clause 44 & 45 of the Terms and Conditions.

41. Breach of contract:

The DUSIB shall have the right to terminate the license and forfeit the security amount, if the successful bidder commits any breach of any of the terms and conditions and instructions of this license. In case the successful bidder wishes to get the license renewed, the DUSIB may at his sole discretion, renew the license for the remaining period, subject to the licensee paying a sum / amount equal to 10% (ten percent only) of the total bid amount as restoration charges along with the license fee for the intervening period.

42. Blacklisting and cancellation of registration:

The successful bidder, if at any time found indulging in over charging / cheating or engaged in any kind of malpractices including default in payment of license fee regularly or non-handing over the site after agreement period to DUSIB etc shall be liable to be blacklisted in which case his security amount / earnest money deposit will be forfeited and registration of parking of Contractor shall be cancelled.

43. Duties of licensee during any repair work undertaken by the DUSIB

The successful bidder shall hand over the vacant and peaceful possession of the parking site to the DUSIB immediately as and when asked for any work to be undertaken by the licensors directly or indirectly through some Agency.

44. Surrender

- (a) In the event of surrender of parking contract by the successful bidder, the right of acceptance of rejection solely rests with the DUSIB.
- (b) In the case of surrender of the contract the successful bidder shall have to give at least 90 days' notice, but not before the lapse of one year of start of contract, so as to enable the DUSIB to examine the notice to take decision and to make alternative arrangement for the running of parking site for the safeguard of revenue.
- (c) In case of surrender/ cancellation of any e-auction for any reason, it shall also be open to C.E.O./ any Officer authorized by him to negotiate with the highest bidder and if he is not available, 2nd highest bidder/ other bidder in order of their bid amounts / any other parties in the interest of revenue of the DUSIB.
- (d) In case of surrender, the security deposit amount shall not be adjusted against the license fee of remaining months and shall be forfeited.
- (e) The successful bidder / contractor, who has surrendered the site, shall not be eligible to participate in the e-auction process of the same site.

45. Jurisdiction Disputes

All disputes shall be under the jurisdiction of Delhi Courts only.

46. Payment of Taxes

All taxes applicable in respect of this agreement including GST shall be payable by the successful bidder at his own level and DUSIB will not entertain any claim at any stage, whatsoever, in respect of the same. The successful bidder shall also absolutely comply with all the extant laws as applicable to the Govt. of NCT of Delhi/U.O.I. etc.

47. Charging of battery of e-Rickshaw

- a. E- Rickshaws have become an important last mile transport facility for citizens of Delhi. They use electricity as fuel instead of petrol/diesel /CNG and would need electrical charging. The parking locations are equipped with or shall be equipped with charging points by the Distribution successful bidder along with necessary
- b. Only Pre-paid electricity connection can be obtained by Contractor from Electricity supply company of the area. Successful Parking contractor may get the existing three phase pre-paid electricity connection transferred to his name immediately after award of the contract. E-Rickshaws may be allowed to be parked and charged from the charging points provided or to be provided. Charges for electricity shall be collected as per directions of Delhi Electricity Regulatory Commission, which pre-paid meters or other similar shall be facilitated by Discom through arrangement. Parking charges for E-Rickshaws shall be collected as per the Parking Contract.
- c. All charges pertaining to the electricity shall be borne and settled by the Contractor without any liability to DUSIB.
- 48. DUSIB will not be responsible for any liability/cost/extension/damages occurred by Contractor on account of this tender process and / or agreement entered into & the Contractor shall be wholly responsible for the same.
- 49. If the Contractor has any outstanding dues of any kind towards DUSIB from this site or any other site or for any other reason, DUSIB shall be entitled to recover the said outstanding dues by adjusting security deposit or any other refundable amount from this site.

Terms and conditions for organizing marriages/social functions at authorized sites are as under:-

1. Eligibility for participation in the e-auction: -

- (a) The bidder must be citizen of India.
- (b) Any adult individual/ Firm/ Company/ Registered Society/ Registered Cooperative Society shall be eligible to participate in e-auction.
- (c) Any individual /Firm/ Company/ Registered Society/Registered Co-operative Society/whose contract has been cancelled in the past or any of its Partner/Proprietor/ Director/Member who have been blacklisted for breach of terms and conditions of the agreement shall not be eligible for offering e-auctions, even if the Individual/ Firm/ Company/Registered Society/ Registered Co-operative Society subsequently changes the character /style/nomenclature/composition of the bidder. The e-auctioning Individual/ Firm / Company/Registered Society/Registered Co-operative Society shall be required to furnish an undertaking to this effect alongwith e-auction form.

- c) The Intending bidder shall safely keep their User ID as well as password, which will be issued by the online e-auction portal upon registration, and which is necessary for e-bidding.
- d) The Intending bidder shall not disclose their User ID as well as password and other material information relating to the bidding to any one and safeguard its secrecy.

Online Bids:

19. Rejection of Bids:

The DUSIB may at its sole discretion and at any time during the evaluation of proposal disqualify any Bidder, if the Bidder has:

(i) Made misleading or false representations in the e-auction or made false reply or documents in support of mandatory criteria.

- (ii) Submitted a proposal online that is not accompanied by required documentation or is non-responsive. In the absence of any documents as required, the concerned party shall be considered as not eligible and in that eventuality their participation in the e-auction shall not be considered.
- (iii) Failed to provide clarifications related thereto, if sought.
- (iv) Information relating to the examination, clarification and comparison of the proposals shall not be disclosed to any bidder or any other persons not officially concerned with such process until the selection process is over. The undue use of confidential information by any bidder related to the process may result in rejection of their bid.
- (v) Any superfluous documents/document not related to the mandatory criteria may result in summary rejection of bid. After expiry of the agreement period, the second party shall hand over the chunk land to the DUSIB in vacant, clean, clear and original condition in peaceful manner.
- 25. If, the department could not finalize the-auction process for further period upto the date of completion of the agreement, the agreement period can be further extended by DUSIB upto a period of 03 months on the same terms and conditions. During this period the e-auction process for awarding new agreement shall be completed by DUSIB. The old agreement will come to an end from the date of executing the new agreement of chunk.

- 26. The successful bidder during agreement period shall be allowed to organize marriages, social/cultural/religious functions, cultural fair, meals /fates, exhibitions by cottage industries, circus after obtaining required permission/Approval/NOC from concerned Authorities/Department.
- 27. The successful bidder/second party shall ensure that all the rules and regulations relating to Fire safety, Law & Order, Pollution, Traffic, Food safety etc. are followed and will also ensure that all orders issued by the Delhi Pollution Control Board, Delhi Police and Delhi Fire services and other agencies from time to time are followed strictly. The successful bidder shall strictly ensure and follow all the rules/regulation and orders/directions of all concerned Government Authorities.
- 28. The bidder shall be responsible for safety and security at the said chunk.
- 29. Adequate communication and public address systems for assistance in emergency situation will be the responsibility of the bidder.
- 30. At his own cost and expenses, successful bidder shall install as many C.C.T.V. cameras as are required. All the entry and exit points of the chunk will be covered. The C.C.T.V. cameras shall always be kept in working conditions. The bidder shall keep the recording of all CCTV cameras for a period of 30 days and DUSIB shall have right to obtain the same any time.
- 31. The successful bidder shall be responsible for ensuring that no nuisance & traffic hindrances/ disturbances are created by the persons / parties organising the functions on the open ground Chunk. The successful bidder shall be solely responsible to the Law enforcement authorities. In case the activities of the successful bidder is found to create traffic problems and /or air/noise pollution or any kind of disturbances /nuisance to the public at large and /or residents of the locality, the DUSIB shall be at liberty to terminate the agreement at any time.
- 32. The successful bidder/ Second party shall ensure to maintain cleanliness and hygienic condition at the Chunk at all times on day to day basis.
- 33. The successful bidder shall be fully responsible to provide adequate and proper parking site/place for the visitors at the allotted chunk and / or at the designated parking site only. All the applicable traffic rules will be followed by the successful bidder/ Second party in and around the Chunk under agreement.

- 34. If the Second party during agreement period intends to surrender the Chunk / without serving any notice to the First party due to any reasons, the full security amount deposited with the First party shall stand forfeited.
- 35. In the event of violation of any terms & conditions by the successful bidder during the agreement period, the DUSIB shall have full right to terminate the agreement and the entire security amount deposited with the DUSIB shall stand forfeited to the DUSIB. Besides blacklisting, legal action shall also be initiated against the Successful bidder for violation of terms and conditions, as and when required. The bidder shall be responsible to pay all outstanding dues upto the date of termination within 03 days. In case the site required by the DUSIB i.e. Licensor for its own a public purposes, the successful bidder shall have to hand over the vacant possession of the site at once.
- 36. If the successful bidder fails to deposit monthly license fee for two consecutive months, then the allotment of chunk(s) shall be terminated and full security amount shall be forfeited. Besides it, the successful bidder shall deposit the entire outstanding monthly license fee within 7 days, failing which DUSIB shall take action for recovery of outstanding dues along with interest @ 18% per annum as arrear of Land Revenue. Further, successful bidder may be blacklisted and legal actions may also be taken against him.
 - 37. The bid amount shall be paid by the successful bidder in proportionate monthly basis in advance i.e. up to 10th day of every month failing which interest at the rate of 18% per annum shall be levied. The agreement may be terminated by the DUSIB without assigning any reason by serving a notice of 60 days and DUSIB shall not be responsible for any kind of damage or cost to the bidder. The successful bidder may surrender the chunk by serving a notice of 90 days to the DUSIB, but not before the lapse of one year of start of contract. In case of termination of the agreement by the DUSIB, the successful bidder will be liable to pay license fee up to the date of termination for agreement. However, in case of surrender of chunk(s) by the successful bidder by serving a notice of 90 days to the first party, the successful bidder will be liable to pay the full proportionate license fee/ bid amount for the three months at the time of submission of application for surrender of chunk(s). In case of surrender/ cancellation of any e-auction for any reason, it shall also be open to C.E.O./ any Officer authorized by him to negotiate with the highest bidder and if he is not available, 2nd highest bidder/ other bidder in order of their bid amounts / any other parties in the interest of revenue of the DUSIB.

- 38. All taxes applicable in respect of this agreement including GST shall be payable by the successful bidder at his level and DUSIB will not entertain any claim at any stage, whatsoever, in respect of the same. The successful bidder shall also absolutely comply with all the extant laws as applicable to the Govt. of NCT of Delhi/U.O.I. etc.
- 39. No pucca structure of any kind will be made/constructed /erected by the second party in any chunk during the agreement period failing which necessary criminal proceedings shall be initiated, besides legal action by all concerned Department/Authorities.
- 40. The successful bidder shall not display or exhibit pictures, poster, statues or other articles which are repugnant to the moral values or are or indecent, immoral or improper character.
- 41. The successful bidder shall not display or exhibit any advertisements or place or put up a hoarding on the outside of the chunk.
- 42. The successful bidder shall have to arrange for systematic parking of the vehicles & peaceful passage of marriage procession from their own means for which the department shall not be responsible. In case of any eventuality and mishap, any penalty/ fine imposed by any agency shall have to be paid by the Successful bidder directly to the agency concerned under intimation to Deputy Director (RP), DUSIB.
- 43. All the necessary permissions required to be obtained from the different departments / agencies shall have to be obtained by the bidder/ second party. The Department shall not be responsible in case of any default caused by the successful bidder/second party. In case of regular violation in this regard, DUSIB shall have a right to terminate the agreement and to forfeit the security deposit.
- 44. The decision of the CEO, DUSIB for acceptance or rejection of bid will be final and shall be abided by all the bidders.
- 45. The successful bidder shall have to abide by all the relevant directions of DUSIB, orders/directions of the Courts of Law in relation to such chunk in question in addition to the terms of this e-auction.

- 46. The successful bidder shall ensure that best quality fire resistant tent & electrical fittings are used during any function. In case of any eventuality the DUSIB shall not be responsible. The successful bidder shall be responsible to comply all the rules/regulations of Fire Department in this regard.
- 47. The successful bidder shall not allow the number of people more than the permissible limit as per applicable laws within the tented premises on the allotted chunk during any function.
- 48. The successful bidder shall not allow organisation of closed door events/ functions in any circumstances and shall also ensure that entry cum exit gates of the tented premises/ pandals are kept sufficiently wide & remain open all the times during the function.
- 49. Only Delhi Courts shall have the jurisdiction over any dispute out of the agreement.
- 50. The successful bidder will follow the guidelines of Disaster Management and obtain necessary clearance from concerned bodies as and when needed.
- 51. Successful bidder must follow the guidelines of Hon'ble Supreme Court orders /rules issued by Competent Authority with regard to Noise/Sound/Air/Pollution.
- 52. The successful bidder should ensure that any unlawful/illegal activity should not take place on the sites and proper law and order should be maintained during various functions.
- 53. The successful bidder shall not use any plastic/non-biodegradable disposable utensils or single use plastic products (such as plastic bottles) to serve the guests. Only non-disposable or biodegradable products shall be allowed.
- 54. If any violation of any of the conditions, a penalty of Rs. 1000/- per day will be levied against the successful bidder. Further, he will also be black listed and not allowed to participate in future e-auction programmes.
- 55. DUSIB will not be responsible for any untoward incident whatsoever at these sites.
- 56. The bidder shall indemnify and keep indemnifying the DUSIB in respect of the losses or damages or expenses of litigation in connection with the sites.

- DUSIB reserves the rights to carry out inspection by any official/officer of the DUSIB to ensure that management of these sites is being done as per E-Auction terms and conditions and directions of DUSIB from time to time.
- The permission by DUSIB shall be for a limited period only for use as per E-Auction terms and conditions and agreement related thereto. This does not create any tenancy rights enjoyable by the selected bidder.
- 59. The land of such site shall always remain the property of DUSIB and the bidder shall not claim any right/title or interest to any right or any nature of easement in relation to or in respect thereto.
- 60. Only Pre-paid electricity connections can be obtained by the Contractor from electricity supply company of the area. All charges pertaining to the electricity shall be borne and settled by the Contractor without any liability to DUSIB.
- 61. DUSIB will not be responsible for any liability/cost/expenses/damages occurred by Contractor on account of this tender process and / or agreement entered into & the Contractor shall be wholly responsible for the same.
- 62. If the Contractor has any outstanding dues of any kind towards DUSIB from this site or any other site or for any other reason, DUSIB shall be entitled to recover the said outstanding dues by adjusting security deposit or any other refundable amount from this site.
