CIRCULAR



The information given in the columns of the seniority list is as per available records & liable to amendment on the basis of information furnished by the concerned officers.

Each employee/ official claiming to belong SC/ST category is requested to inform the fact within the stipulated period along-with necessary documents and evidence, failing which it will be presumed that he is not a member of SC/ST and his seniority may be fixed as per Govt. of India's instructions on the subject.

Due note may be taken of the fact, that whether an official is confirmed or temporary and his position in the seniority list will be finalized in accordance with the Govt. of India's order on the subject.

It may also be noted that each concerned official/ employee will be held responsible in case any of his/ her entries in the tentative seniority list are incorrect or missing (including such entries as may be to his advantage) and the same has not been pointed out by the concerned officials.
