NOTICE INVITING EXPRESSION OF INTEREST FROM  
NATIONALIZED BANKS.

Delhi Urban Shelter Improvement Board, an Autonomous Body under the Government of NCT of Delhi from its Head Office located in Punarvas Bhavan, I.P. Estate New Delhi-110002 has been operating 15 Banks Accounts with the Central Bank of India, DDA, Slum & JJ Wing Vikas Kuteer, I. P. Estate, New Delhi-110002.

The Central Bank of India has recently taken a decision to merge its aforesaid branch with the branch of Central Bank of India located in Vikas Minar, New Delhi-110002. There is a considerable distance between the offices of DUSIB located in Vikas Kuteer and Vikas Minar Branch of CBI. It is not feasible for DUSIB to operate all the 15 Accounts with Vikas Minar Branch from such a distance.

In order to ensure smooth functioning of the accounts branches of DUSIB and to have effective control over the day- to-day work relating to banks transactions / receipts, DUSIB intends to get opened a branch/ extension counter of any nationalized bank in its premises at Vikas Kuteer. DUSIB's yearly expenditure under the 15 Banks accounts is more than 400.00 Cr and matching receipts are booked under the accounts by way of recovery of dues from the general public against the assets of DUSIB, grant-in-aid and loan from the Government of NCT of Delhi etc.

Expressions of Interest are invited from the nationalized banks upto 27<sup>th</sup> April, 2021 for opening of a branch or extension counter in the premises of DUSIB at Vikas Kuteer.
