CIRCULAR

Each officer claiming to belong to SC/ST category may be requested to inform the fact within the stipulated period along-with necessary documents and evidence, failing which it may be presumed that he is not a member of SC/ST and his seniority may be fixed as per Govt. of India's instructions on the subject.

Due note may be taken of the fact whether an official is confirmed or temporary, his position in the seniority list will be finalized in accordance with the Govt. of India's order on the subject.

It may also be noted that each concerned officer may be held responsible in case any of the entries in the tentative seniority list are incorrect or missing (including such entries as may be to his advantage) and the same has not been pointed out by the concerned officer.
