CIRCULAR


The last final seniority list of Junior Engineer (Civil) was circulated in the department on 24.08.2008.

The information given in the columns of the seniority list as per available records & may be liable to amendment on the basis of information furnished by the concerned officers.

Each employees/ officials claiming to belong SC/ST may be requested to inform the fact within the stipulated period along-with necessary documents and evidence, failing which it will be presumed that he is not a member of SC/ST and his seniority will be fixed as per Govt. of India's instructions on the subject.

It may also be noted that each concerned officials/ employees may be held responsible in case any of the entries in the tentative seniority list are incorrect or missing (including such entries as may be to his advantage) and the same has not been pointed out by the concerned officials within scheduled time.
