## ORDER

An appeal was filed by Sh. Puran Lal against the reply of PIO furnished to the appellant with respect to RTI application registered vide ID No. 93/AD(EZB)/DUSIB/B/2022 dated b.06.22 with JJR Branch, DUSIB.

The appellant had filed an application under RTI Act 2005 seeking information with respect to the mutation of plot number CPA 168 New Seelampur, Delhi-53 and the order of any Hon'ble Court's order restraining it.

The appellant, now vide the appeal has alleged that, he has not been provided the correct reply by the PIO and requests for directions to PIO to provide the correct and complete information. During the hearing it was stated that, no information has been provided in respect of action taken on the complaint filed by him in 1997. It was further alleged that, in 1997, a mutation application was tendered to the zonal officer but neither any action was taken nor information was given to him in this regard.

The PIO submitted that, the correct reply has been furnished to the appellant as available in the records.

Perused the appeal filed by the appellant and the arguments preferred by the PIO during the hearing afforded to the appellant Sh. Puran Lal. Perusal of the reply furnished by the APIO, vide letter dated 1.07.22 reveals that, reply to the information sought vide question 3 and 5 is indiscreet and unjustified to the extent that, the PIO failed to inform about the court case referred to in the reply.

Whereas after considering all the arguments of both the parties, I request Sh. Puran lal to again file a fresh application for mutation to the Zonal Officer (EZB), who shall dispose the same in 15 days with speaking remarks.

In case the appellant is not satisfied with this order, he may file 2nd appeal with Chief Information Commissioner at CIC Bhawan, Baba Gang Nath Marg, Munirka, New Delhi under section 19(3) of RTI Act, 2005 within 90 days of receipt of the decision of First Appellate Authority.

Appeal disposed of accordingly.
