**OFFICE ORDER**

**Subject: Debarment from tendering for Six Months in Delhi Urban Shelter Improvement Board,  
GNCT of Delhi.**

WHEREAS; the above noted e-tender was invited by this office vide NIT No. & Date cited above. The NIT was published on <https://govtprocurement.delhi.gov.in> vide Tender Id No. **2022\_DUSIB\_230353\_1**.

WHEREAS; M/s Sachin Choudhary, Govt. Contractor, enlisted with East Delhi, Municipal Corporation, Central Establishment Department-II in Class V(Civil) to Class-IV(Civil) vide Registration No. 75/IV(Civil) dated 21.02.2022 valid upto 13.02.2027, the tenderer here-in had submitted e-bids in the above-mentioned e-tender.

WHEREAS; M/s Sachin Choudhary, Govt. Contractor, was found to be L-1 agency after opening of the Financial bids on 18.10.2022..

WHEREAS; the e-tender was processed by this office for acceptance of **Rate & Agency** by the competent authority in respect of the L-1 Agency, M/s Sachin Chaudhary, Govt. Contractor.

WHEREAS; M/s Sachin Choudhary, Govt. Contractor had withdrawn their bid vide letter received in this office vide Dy. No. 1352 dated 14.11.2022 citing the reasons as, " *quoted wrong rates by mistake and could not able to execute the work on quoted rates*".

WHEREAS; the matter was brought into the notice of the competent authority to take a considered view because the work is of a very urgent nature in as much as M.S. gates were proposed to be installed for security of the residents of different lanes at X- Block Nangloi, Ph-I, Delhi on the recommendation of the area MLA due to sustained public demand. The public representative and local residents of the area have been pressing for early execution of the work under the plan scheme of the Govt of NCT of Delhi meant for SC Basties.

WHEREAS; a show cause notice was issued to M/s Sachin Chaudhary, Govt. Contractor vide this office letter bearing No. WG/4840/47/EEC-3/AE-II/2021-22/D-677 dated 21.01.2023 to show cause as to why action for willful withdrawal of bid be not initiated against them.

WHEREAS; M/s Sachin Chaudhary, Govt. Contractor not replied to the SCN within stipulated period i.e. 07 days vide letter dated 21.01.2023 which was put up for consideration of the competent authority.

And WHEREAS; the competent authority after careful consideration of the matter and urgency of work has directed to-

- (A) Forfeit the Earnest Money Deposited by the agency to the extent of 50% only and  
(B) Debar the agency concerned from further tendering in DUSIB, GNCT of Delhi for a period of six months from the date of order.

Now THEREFORE; it is ordered that a sum of Rs. 30,000/- being 50% of the total EMD (Rs.60,000/-) be forfeited at once and the balance EMD by the agency be refunded forthwith as per rules. The agency M/s Sachin Chaudhary, Govt Contractor shall remain debarred from further tendering for a period of six months from the date of issue of this order.
