

2. The focus of NPCSCB is on promoting ease of living and ease of doing business, by considerably enhancing the citizen government interface. This involves creation of both functional and behavioral competencies among the civil servants.

It was informed that the National Programme for Civil Services Capacity Building (NPCSCB) has six key pillars which are as under:-


- (a) Policy Framework


