CIRCULAR

Subject: Submission of Immovable Property Return for the year-2021  
by the officers of Group 'A' & 'B' -reg.

In response to this Office Circular dated 10-01-2023 and subsequent reminder dated 07-03-2023 on the subject cited above, it is observed that the IPR for the year ending 31-12-2022 in respect of officers **(list enclosed overleaf )** have not yet been received in this office.

Further, attention is invited to following provisions of the CCS  
(Conduct) Rules:

- It may be impressed upon that failure on the part of a Government Servant to file the returns in prescribed time can form good and sufficient reason for instituting disciplinary proceedings against them. Strict action may be taken against employees who fail to submit the return in time or furnish wrong information.
- If the officers fail to submit the return, vigilance clearance should be denied to them and they should not be considered for empanelment for senior level post.

Therefore, it is once again requested that officers who have not filed their IPR for the year ending 31-12-2022 so far, file the same **within seven days** positively, failing which the matter will be placed before higher authority for obtaining appropriate direction/action against the defaulters.

This may kindly be accorded 'TOP PRIORITY'.
