

OFFICE ORDER

For effective implementation of the provision of RTI Act, 2005, in supersession of all previous orders, the following officers are designated as Public Information Officers (PIOs), First Appellate Authorities (FAAs) and Asstt. Public Information Officers (APIOs) with immediate effect:

1. All Executive Engineers (Civil & Electrical), All Dy. Directors, Architects, All Dy. CAs & Law Officer are designated as Public Information Officer in respect of branches/divisions under their control. In case of Office of Competent Authority, Tis Hazari Court, Sectt. of Member (Admn) and Sectt. of Chief Executive Officer, Dy. Director (Admn) shall be the Public Information Officer. In case of Sectt. of Member (Finance) and Member (Engineering), respective Dy. Chief Accountant and Executive Engineer (Coordination) shall be the Public Information Officer.
2. All Directors, Superintending Engineers (Civil & Electrical), Budget & Finance Officer (B&FO) are designated as First Appellate Authority (FAA) in respect of Branches/Divisions under their control. In case of Office of Competent Authority, Tis Hazari Court, Sectt. of Member (Admn) & Sectt. of Chief Executive Officer, Director (Admn) shall be the First Appellate Authority (FAA). In case of Sectt. of Member (Finance) and Member (Engineering), Budget & Finance Officer (B&FO) & Superintending Engineer (Coordination) shall be the First Appellate Authority (FAA) respectively. Further, in case of leave of any FAA, his/her link officer shall be the FAA during his/her leaves period.
3. All Assistant Directors, Assistant Engineers, Accounts Officers, Asstt. Architects, Tehsildar, Survey Officers and Jr. Law Officer (JLO) are designated as Asstt. Public Information Officer.
