DELHI URBAN SHELTER IMPROVEMENT BOARD GOVT. OF N.C.T. OF DELHI REHABILITATION BRANCH

Updated information in r/o 17 manuals under Section-4 (1) (b) of RTI Act-2005.

- (I) Particulars of organization, function and duties:- Rehabilitation Branch is dealing with the implementation of Delhi Slum & JJ Rehabilitation and Relocation Policy-2015 (renamed as Mukhya Mantri Awas Yojna-- MMAY) and the Draft Protocol for removal of jhuggis and JJ Bastis in Delhi.
- (II) The powers and duties of it's officers & employees:- Rehabilitation Branch is dealing with the implementation of Delhi Slum & JJ Rehabilitation and Relocation Policy-2015 (renamed as MMAY) and the Draft Protocol for removal of jhuggis and JJ Bastis in Delhi. The office of the Rehabilitation Branch is situated at Raja Garden, Opposite Shivaji College Sports Complex, New Delhi-110027.

Besides, routine official work, each Deputy Director and Assistant Director posted in Rehabilitation Branch is the Member of Eligibility Determination Committee (EDC) which determines the eligibility of JJ dwellers alongwith member of Land Owning Agency. EDC determines the eligibility as per provisions of Delhi Slum & JJ Rehabilitation and Relocation Policy-2015 (MMAY) and the provisions of the Draft Protocol for removal of jhuggis and JJ Bastis in Delhi which was approved by the Urban Shelter Improvement Board in its 16th Board Meeting held on 11.04.2016. The said policy amended in the 18th Board Meeting held on 06.02.2017. The Delhi Slum & JJ Rehabilitation and Relocation Policy-2015 issued on 11.12.2017 by the Urban Development Department, GNCTD. The copy of the Policy and Protocol are available on the DUSIB's website (delhishelterboard.in).

EDC issues eligibility or ineligibility letter on the same day. In case a JJ dweller is declared eligible by the EDC, eligible JJ dweller has to deposit the beneficiary share money amount mentioned in the eligibility letter in the given time. However, in case a JJ dweller is declared ineligible by the EDC, it gives reasons of ineligibility in the ineligibility letter. In case a JJ dweller is declared ineligible he/she may file an Appeal against the order of EDC in the office of the Principal Director (Rehabilitation) within one month of issuance of ineligibility letter.

Deputy Director and Assistant Director posted in Rehabilitation Branch are also responsible for processing cases with Land Owning Agency for relocation of JJ basti including issuing demand notice to the Land Owning Agency, holding draw of flats and removal of JJ basti and all other works assigned to them by the Seniors.

(III) The procedure followed in the decision making process:- As per above said Policy, Delhi Urban Shelter Improvement Board (DUSIB) is the Nodal Agency for implementation of this policy as per the mandate given to it under the provisions of Delhi Urban Shelter Improvement Board Act, 2010.

As per said Policy, JJ Bastis which have come up before 01.01.2006 shall not be removed (as per NCT of Delhi Laws (Special Provisions) Second Act, 2011) without providing them alternate housing. Jhuggis which have come up in such JJ Basti before 01.01.2015 shall not be demolished without providing alternate housing: (this is in supersession of the earlier cut-off date of 04.06.2009 as notified in the guidelines of 2013).

As per Clause 2(i) of the said Policy, DUSIB shall provide alternative accommodation to those living in JJ Bastis, either on the same land or in the vicinity within a radius of 5 Kilometres. However, in rare cases DUSIB may relocate a JJ basti.

Further, any Land Owning Agency will not demolish any Jhuggi Jhopri Basti which is eligible as per Para 2(i) of the Policy unless:

- 1. There is any Court order
- 2. That basti has encroached a street, road, footpath, Railway safety zone or a park
- 3. The encroached land is required by the land owning agency for specific public project as envisaged in The National Capital Territory of Delhi Laws (Special Provisions) Second Act. 2011, which is extremely urgent and can't wait.

In these circumstances, the land owning agency shall bring the proposal before DUSIB. If DUSIB is satisfied and permits demolition, then DUSIB shall make all efforts to relocate the jhuggis in that JJ Cluster, clear the land and hand it over to land owning agency within next six months after the date of DUSIB resolution. In such circumstances, the land owning agency shall pay such amount to DUSIB in advance, which meets the cost of construction of alternate dwelling units, cost of the land at Circle Rate which will be on institutional rate at which DUSIB has purchased and cost of relocation. However, the beneficiary contribution as well as the contribution made by the Government of India if any, towards the cost of construction of dwelling units, will be deducted from the aforementioned cost of rehabilitation.

Under this Policy the steps of rehabilitation/relocation of JJ Basti would be as under:

(a)	Land Owning Agency to send
	proposal for removal of the JJ Basti
	to DUSIB, sufficiently in advance
	alongwith commitment to make
	payment towards cost of rehabilitation.

As per Protocol, proposal will be examined by DUSIB. If JJ Basti was in existence prior to 01.01.2006, DUSIB will notify said JJ Basti under Section 2(g) of the DUSIB Act, if not earlier notified, proposal will be placed before the Board for in-principle approval for rehabilitation.

(c)	Holding camp for Eligibility Determination by the Committee	Members of the Committee: (i)Deputy Director- Chairman (ii)Assistant Director- Member (iii)Representative of Land Owning Agency- Member The EDC is assisted by the HCs/UDCs/LDCs/DEOs
(d)	Computerized Draw of flats	Computerized draw by the Committee constituted and approved by the CEO, DUSIB.

All the functions are discharged as per Delhi Slum & JJ Rehabilitation and Relocation Policy-2015 (renamed as MMAY) and the Draft Protocol for removal of jhuggis and Bastis in Delhi and on the basis of instruction/order/approval of Competent Authority & Senior Officers.
