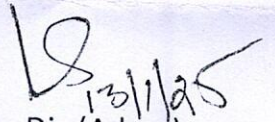

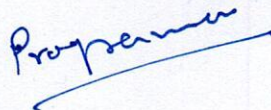

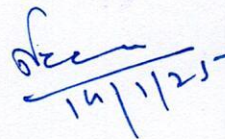

ORDER

Sub: Enforcement of MCC - Directions for MLALAD/ Unauthorised Colonies/ DUSIB Schemes/ DISCOM works sanctioned by UD/ Swatch Bharat Mission/ AMRUT Scheme and any other work under Central or State Sector Schemes.

Election Commission of India has announced the schedule for Delhi Assembly Elections, 2025 and Model Code of Conduct has immediately come into force. Accordingly, the following directions may be noted for strict implementation regarding the above mentioned schemes:

- (i) There will be no fresh release of funds under any scheme.
- (ii) There will be no fresh sanctions or administrative approval to start any new scheme.
- (iii) In cases where sanction order has been issued and tenders have not been floated, no tender will be floated.
- (iv) Where tender process has been completed but work has not been awarded, there will be embargo on award of work.
- (v) In cases where work have been awarded but physically the work has not commenced on the ground till 06.01.2025, under no circumstances, work will commence.
- (vi) Fresh directions will be issued after Model Code of Conduct is over regarding the above directions.

2. Keeping in view of the above, all executing agencies are hereby directed to submit a STATUS REPORT in respect of earlier sanctioned works (falling in the above three categories) under MLALAD and all other schemes as mentioned above, by 08.01.2025, 11:00 AM, positively.
