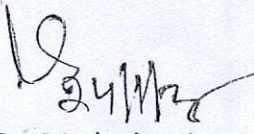

Madam/Sir,

In connection to the subject mentioned above, I am directed to draw your kind attention to "The Delhi Prevention of Defacement of Property Act, 2007" (Delhi Act 1 of 2009). The referred Act provides for the prevention of defacement of properties and for matters connected therewith or incidental thereto, in the Nation Capital Territory of Delhi (Copy enclosed).

Election Commission of India vide its press Note dated 07.01.2025 has announced the Schedule for Delhi Legislative Assembly Election-2025 and Model Code of Conduct has come into force w.e.f. 07.01.2025 (copy may be downlond <https://election24.cci.gov.in/docs/press-note-no-23.pdf>). from ECI website

The Commission has issued instructions regarding immediate action to be taken for enforcement of the provisions of Model Code of Conduct after announcement of Delhi Legislative Assembly Election-2025 and one of the important directions is regarding defacement of property. In the instructions it is specified that immediate action may be taken within 24 hours, 48 hours and 72 hours from the date of announcement of Election. Copy of the same is enclosed for ready reference.



Accordingly, It is requested to guide this office AC-09 (Kirari) to prevent defacement of Property, display of advertisement on government owned vehicles and other campaign related items for DLAE-2025 and action taken/ compliance report may be sent to this office at roac09kirari@gmail.com daily i.e. after 24 hours(i.e. up to 5PM on 08.01.25) , 48 hours(i.e. up to 5PM on 09.01.25), 72 hours(i.e. up to 5PM on 10.01.25) from the date of announcement of Election.
