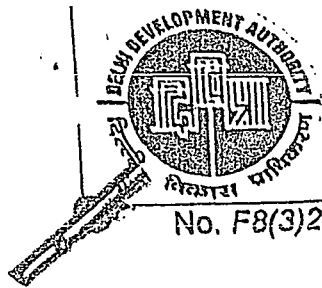

F & E Circular No. 01/2025

In supersession of F&E circular No. 07 dt.12.06.2017, the medical OPD limits for all the serving as well as retired employees of DDA have been revised upwards. The upward revision of Medical Allowance to the serving employees in the pay level 1 to 5 (Pay Matrix as per 7th CPC) is also effected. The ceiling limits as indicated in column No. (D) shall be applicable from the financial year 2024-25 (w.e.f. 01.04.2024).
