ORDER

Sub: Constitution of Coordination Committee to deal with Home, Police and Law & Order related matters

1. In order to ensure effective coordination and communication among various departments and agencies dealing with Home, Police and Law & Order subjects including related subjects such as law, transport, public works, municipal Administration, social welfare, education etc., a Coordination Committee is hereby constituted under the chairmanship of the Chief Secretary, Delhi with immediate effect.

2. Composition of the High Level Coordination Committee shall be as follows:

(i) Chief Secretary, Delhi	Chairman
(ii) Commissioner of Police	Member
(iii) ACS/Pr. Secretary/Secretary (Home), GNCTD	Convener
(iv) Vice Chairman, DDA	Member
(v) ACS/Pr. Secretary/Secretary (PWD)	Member
(vi) ACS/Pr. Secretary/Secretary (Education)	Member
(vii) ACS/Pr. Secretary (Transport)	Member
(viii) ACS/Pr. Secretary/Secretary (Law, Justice & LA)	Member
(ix) Commissioner, MCD	Member
(x) CEO, DUSIB	Member

3. Terms of Reference of the Committee shall be as follows, but not limited to;

- To coordinate and facilitate effective communication among departments/agencies dealing with Home, Police, Law & Order subjects including the related subjects mentioned also.
- To identify and address issues related to home, police, law & order.
- To develop and implement strategies for improving public safety and security.

4. The Committee shall meet every Tuesday at 11.30 AM at the Chief Secretary, Conference Room, 5th floor and if the day happens to be a holiday, the meeting shall take place on the next working day. The Chairman shall preside over the meetings, and the minutes shall be recorded and circulated to all members. The Chairman may also co-opt any member to be a part of the coordination committee and its deliberations.
