CIRCULAR

In a matter of procurement of IT items, the procurement committee which also consisted of Academicians, did not obtain clearance from TEC of IT Department and concurrence of Finance Department.

2. Departmental proceedings were initiated against the officers / academicians and during personal hearing before the Hon'ble Lieutenant Governor, Delhi being, the Disciplinary Authority, the Hon'ble L.G., Delhi has observed / directed as under:-

"I express my concern over assignment of ministerial duties to academicians, which is significantly in deviation from their designated roles and responsibilities leading to potentially compromising quality of education. Therefore, I advise to discontinue the practice of assigning ministerial tasks to academicians to preserve the integrity of academic functions. Further, "Technical Evaluation Committees and Financial Evaluation Committees in all the departments should invariably have members of administrative and I of finance background to ensure adherence of the provisions of General & Financial Rules in true letter and spirits."

Governor, Delhi are conveyed to all the Additional Chief Secretaries / Principal Secretaries / Secretaries / Head of Departments of all departments / Autonomous Bodies etc. of Govt. of NCT of Delhi with the request to ensure the compliance of the same in letter & spirit and to avoid the recurrence of such incidents.
