This issues with the prior approval of Competent Authority.

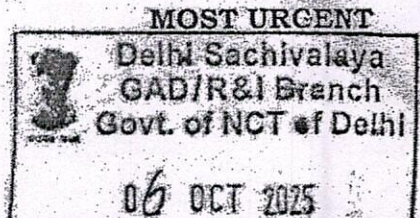
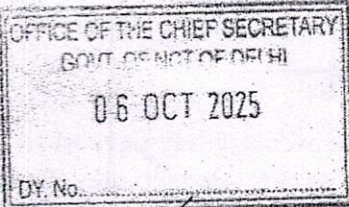
