





5. Shifting of telephone lines and cable will be charged separately.
6. The AMC charges include periodical maintenance and attendance of calls against breakdown reported to service centre on or mail on
7. The breakdown and periodical maintenance will be carried out between office hours 9AM - 6PM on working days Monday to Friday.
8. In case of any complaints, the company shall attend the same between 24 - 48 hours.
9. The contractor will replace of the concerned machine with only genuine spares.
10. If the services of the second party are found unsatisfactory, the AMC may be cancelled on specified one month notice period.
11. All the dispute arising out of or in any way connected with this agreement shall be deemed to have arisen in New Delhi and the courts in New Delhi shall have jurisdiction to determine the same.
